#### Matters discussed:

- The BAC-B Vice-Chairperson formally presided the Pre-Bidding Conference for BS-004-19. He acknowledged the presence of the BAC-B members, TWG, Secretariat, observers and prospective bidders' representatives.
- II. The BAC-B stated that no prospective bidder purchased the bidding documents as of the time being. The BAC-B then explained that the purpose of having a pre-bid conference is for the prospective bidders to ask their queries and clarify the technical and financial parameters regarding the project for a good procurement process.
- III. The Secretariat presented the details of the project.
- IV. Subsequently, the BAC-B asked the prospective bidders if they have any questions or clarifications:

Ms. Gutierrez-Jose from Trust Trade raised her concerns:	The BAC-B together with the TWG and Secretariat discussed their concerns:
<ol> <li>Can we request for an extension of Delivey Period? It may take some time to process the permits from PNP, import permits and other documents, so we would like to request for 180 calendar days period.</li> </ol>	<ol> <li>We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.</li> </ol>
2. Delivery site indicated in the Bid Data Sheet is in the NIA Central Office, however, there is a list of Delivery Sites into different offices across the Philippines. It is also stated that we will be the one to process and shoulder the Permits to Transfer. We would like to clarify, if we would deliver this to the specific offices of the regional offices?	<ol> <li>The delivery will be in the Regional Offices. This will be discussed further and be included in the Supplemental Notice if ever there will be further clarifications.</li> </ol>
3. As a follow up clarification, we would like to inform you that we can process in securing Permit to Transfer (PTT), but technically we are not allowed to do the actual transfer since the pistols are already NIA's property. In addition, the PTT costs Php 200.00 each. Moreover, to process the PTT, NIA should submit a request letter to PNP and they will require the exact addressess of the destinations. Lastly, PTTs have expiration dates.	<ol> <li>This will be discussed further and be included in the Supplemental Notice if ever there will be further clarifications.</li> </ol>

4.	Are the Test Parameters indicated in the bidding documents applicable for both Post Qualifciation and Pre-acceptance stage?	4.	Yes. Test Parameters will be appicable for both Post Qualification and Pre- acceptance stage. Two pistols will be used for Post Qualification. The remaining pistols will undergo the functional test which will be fired using 15 rounds each.
5.	Are all pistols be subjected to an endurance firing test (20,000 rounds)?	5.	Only one pistol shall be subjected to the endurance firing test. It shall be selected from the two pistols that underwent the Post Qualfication evaluation.
б.	In your Test Parameters, all 155 units will be presented during the Post Qualfication since the 2 pistols for Post Qualification evaluation will come from the pool of 155 units of pistols.	6.	We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.
7.	We would like to inform you that the 2 pistols that will undergo the magnaflux test during Post Qualification will be dismantled and tested and will be inoperative. Are the 2 pistols still included in the 155 units of pistols to be delivered?	7.	We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.
8.	Your required markings will not be engraved in the pistols during the Post Qualfication stage.	8.	Yes. It is not yet required during the Post Qualfication stage.
9.	We will be testing a pistol for endurance firing test (20,00 rounds) for five days. This seem impractical since your are only procuring 155 units compared to the PNP whose procuring thousands of units. Can we suggest that you acquire a copy of test result from the PNP of the endurance firing test since you patterned this with their parameters.	9.	We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.
10	It is stated in the bidding documents that we will be the one to request for a Philippine National Police – Directorate for Research and Development (PNP-DRD) Personnel for the testing. We can try to obtain one , but, we cannot assure you of this since we are not a government entity and it will be better if NIA will be the one coordinating with PNP-DRD.	10	. We can takeover the coordination to secure a PNP-DRD Personnel and this will be discussed further and be included in the Supplemental Notice if ever there will be further clarifications.

12. What is the definition of the acronym "IAT" stated in the bid documents?	<ol> <li>IAT means Inspection and Acceptance Team. It is defined in the bidding documents.</li> </ol>
13. Who will conduct the actual firing during the testing stage?	<ol> <li>We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.</li> </ol>
14. Any preference for the firing range?	14. There is no preference for the firing range.
15. Testing will be done in the firing range as stated in the bid docs. We want to ask for a clarification if the pistols will be delivered straight to the firing range or it will be delivered at NIA-CO then be transported to the firing range for testing. Again, this will require permit to transfer.	15. We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.
16. Please elaborate further on the topics to be tackled in the refresher's course.	16. We will take note of this and include it in the Supplemental Notice if there will be clarifications regarding this matter.
17. In the Technical Specifications, the "15 rounds" pertains to the minimum or maximum of the magazine capacity. If you wish to reflect your needed ammunition, please specify it clearly in the Technical Specifications.	17. We will have to modify this since we interpreted the Magazine Capacity as the number of ammunition. So we will set the minimum or maximum of the magazine capacity and its corresponding ammunition to better capture our requirements.
