***TWG reminded the prospective bidders that the Hotplate will be utilized for digestion and not titration.	
<ol> <li>For the Analytical Balance, will the pan size matter for this item matter? We can provide 85mm instead of the indicated 90mm.</li> </ol>	<ol> <li>We set the pan size to 95mm so that materials can fit in. However, we will tak note of your comment.</li> </ol>

  - c. The bidder should fill out the Bid Securing Declaration and Omnibus Sworn Statement, including the Jurat portion indicating the Government Issued ID and Community Tax Certificate; and
  - d. For the Bid Form (Tables for Goods offered Abroad or within the Philippines), the bidder shall fill this out completely and shall not leave any field blank.
