INVITATION TO BID PROCUREMENT OF SERVICE PROVIDER FOR THE PHASE II OF ENHANCED FARMLAND GEOGRAPHIC INFORMATION SYSTEM (FGIS DIGITIZATION OF PARCELLARY MAPS AND FARMLAND DATABASE DEVELOPMENT) ITB NO. BS-003-2020

- 1. The National Irrigation Administration (NIA), through the Corporate Operating Budget (COB) for 2020 intends to apply the sum of Forty Nine Million Seven Hundred Forty Eight Thousand Five Hundred Twenty Pesos and 50/100 (Php 49,748,520.50) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Service Provider for the Phase II of enhanced Farmland Geographic Information System (FGIS Digitization of Parcellary Maps and Farmland Database Development). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NIA now invites bids for Procurement of Service Provider for the Phase II of enhanced Farmland Geographic Information System (FGIS Digitization of Parcellary Maps and Farmland Database Development) Delivery of the Goods is required One Hundred Fifty (150) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to Procurement of Service Provider for Software Development. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock

belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain information from BAC-B Secretariat, c/o Procurement Section, Procurement and Property Division, Ground Floor, NIA Bldg. A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours (8:00 AM - 5:00 PM).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on June 8, 2020 to June 30, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (25,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The NIA will hold a Pre-Bid Conference on June 16, 2020, 2:00 PM at Classroom A, 3rd Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 30, 2020, 1:30 PM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on June 30, 2020, 2:00 PM at Classroom A, 3rd Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The *NIA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
