## **INVITATION TO BID**

## Supply and Delivery of Brand New Thirty Four (34) units Pick-up Truck, Double Cab, 4x4, DED, 3000 cc (max.) Invitation to Bid No. NIACO-S-5R

- 1. The National Irrigation Administration, through the Government of the Philippines (GOP) /General Appropriations Act (GAA)-2018 (COB) (CY 2018 Continuing Appropriation) intends to apply the sum of **Fifty Seven Million Eight Hundred Thousand Pesos (PhP57,800,000.00)** being the Approved Budget for the Contract (ABC) to payments under the Contract No. NIACO-S-5R. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the Supply and Delivery of Brand New Thirty Four (34) units Pick-up Truck, Double Cab, 4x4, DED, 3000 cc (maximum). Delivery of the Goods is required within Thirty (30) calendar days from receipt of Notice to Proceed. Bidders should have completed a single contract, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) of ABC or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from the BAC-A Secretariat, 6<sup>th</sup> Floor, NIA Building "A", EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 8:00 AM to 5:00 PM. Monday to Friday.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting from **September 4, 2020** to **September 30, 2020** at the address below and upon submission of letter of intent and payment to the NIA Cashier a non-refundable fee for the Bidding Documents in the amount of Fifty Thousand Pesos (PhP50,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the NIA website http://www.nia.gov.ph/, provided that Bidders shall pay to the NIA Cashier a nonrefundable fee for the Bidding Documents not later than the submission of their bids.
