**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT OF SUPPLY AND DELIVERY OF  
VARIOUS BRAND NEW TRANSPORTATION EQUIPMENT FOR NIA REGION 2  
CONTRACT NO. NIACO-S-19**

**WHEREAS**, a Technical Working Group (TWG) was duly constituted from a pool of technical, and legal experts in the National Irrigation Administration (NIA) who shall perform the following functions to assist the Bids and Awards Committee -A (BAC-A) in the procurement of Various Brand-New Transportation Equipment for NIA Region 2:

1. Review of the Technical Specifications, Scope of Work, and Terms of Reference;
2. Review of Bidding Documents;
3. Eligibility Screening;
4. Evaluation of Bids;
5. Post-Qualification; and
6. Resolution of Request for Reconsideration.

Copy of the Memorandum regarding the Creation/Constitution of BAC-A Technical Working Group for the above-mentioned project is attached hereto as **Annex "1"**;

**WHEREAS**, the BAC-A held a Pre-Procurement Conference on October 11, 2024, to determine the readiness of the procurement of Various Brand-New Transportation Equipment for NIA Region 2. Copy of the minutes of pre-procurement conference is attached as **Annex "2"**;

**WHEREAS**, the National Irrigation Administration advertised/posted in the PhilGEPS and NIA website (attached as **Annex "3"**) the Invitation to Bid No. NIACO-S-19 for the Supply and Delivery of Various Brand New Transportation Equipment for NIA Region 2 on October 18, 2024. The Invitation to Bid was also posted in conspicuous places within the NIA premises;

**WHEREAS**, in response to said advertisement, the following suppliers submitted their Letters of Intent (LOIs) (**Annexes "A-4" and "A-5"**), and purchased the bid documents, to wit:

**Lot 1 - Supply and Delivery of Three (3) units Brand New Pick-up Truck**  
Approved Budget of the Contract (ABC) = PhP4,863,000.00

- 1) GLOBAL EXCELLENCE MOTORS, INC.

**Lot 2 - Supply and Delivery of Thirteen (13) units Brand New Motorcycle**  
Approved Budget of the Contract (ABC) = PhP1,560,000.00

- 1) WORLD SOLUTION TECHNOLOGY, INC.



**WHEREAS**, observers from the Commission on Audit (COA), Philippine Institute of Civil Engineers (PICE), Philippine Chambers of Commerce, Inc. (PCCI), NIA-Internal Audit Services (NIA-IAS), and National Irrigation Administration Employees Association of the Philippines (NIAEASP), were invited to attend the Pre-bidding Conference scheduled on October 30, 2024; 10:00 A.M. at BAC-A Conference Room, 6<sup>th</sup> Floor, Building A, NIA Complex, EDSA, Quezon City. Copies of the letters of invitation are hereto attached as **Annexes "6" to "10"**;

**WHEREAS**, the Pre-bidding Conference held on October 30, 2024 was attended by five (5) prospective bidders, copy of the Minutes of the Pre-Bidding Conference attached as **Annex "11"**;

**WHEREAS**, observers from the COA, PICE, PCCI, NIAEASP, and NIA-IAS, were all invited to attend the Opening of Bids scheduled on November 13, 2024; 1:30 PM, at BAC-A Conference Room, 6<sup>th</sup> Floor, Building A, NIA Complex, EDSA, Quezon City;

**WHEREAS**, on November 13, 2024, all prospective bidders submitted their bids on time, as follows:

**WHEREAS**, the bids submitted were opened and read in public to determine if they contain all the bid requirements for the Eligibility, Technical, and Financial Components, using a non-discretionary "**pass/fail**" criterion, copy of the checklist of documents comprising the first envelope of the bid are attached hereto as **Annexes "12" and "13"**;

**WHEREAS**, the eligibility, technical, and financial components of the bid submitted by GLOBAL EXCELLENCE MOTORS, INC., and WORLD SOLUTION TECHNOLOGY, INC. were rated "**PASSED**" by the BAC-A, and were informed that the same would be subjected to detailed bid evaluation. Copy of the minutes of bid opening is attached as **Annex "14"**;

**WHEREAS**, the Approved Budget for the Contract (ABC) and the financial bid proposals rated passed by the BAC-A as read in public were tabulated as follows:

**WHEREAS**, in the BAC-A meeting held on November 19, 2024, the Technical Working Group (TWG), in their presentation, reported that the bid of GLOBAL EXCELLENCE MOTORS, INC., and WORLD SOLUTION TECHNOLOGY, INC. were complying and passed all the requirements in the bidding documents, copy of the Detailed Evaluation of Documentary Requirements for Lot Nos. 1 and 2 are attached as **Annexes "17" and "18"**;

**WHEREAS**, on the same meeting, the BAC-A agreed with the findings of the TWG, and declared the bid of *GLOBAL EXCELLENCE MOTORS, INC.*, and *WORLD SOLUTION TECHNOLOGY, INC.* as the Single Calculated Bid (SCB) for Lot Nos. 1 and 2, respectively. Copy of the minutes of meeting is attached as **Annex "19"**;

**WHEREAS**, the BAC-A informed *GLOBAL EXCELLENCE MOTORS, INC.*, and *WORLD SOLUTION TECHNOLOGY, INC.* that their bid was declared as the SCB for Lot Nos. 1 and 2, respectively, and required them to submit within five (5) calendar days, the post-qualification documents, copy of the letter attached as **Annexes "20" and "21"**;

**WHEREAS**, the BAC-A Chairperson instructed the TWG and Secretariat to conduct the post-qualification process on the bid of *GLOBAL EXCELLENCE MOTORS, INC.*, and *WORLD SOLUTION TECHNOLOGY, INC.* from November 21, 2024, to November 26, 2024;

**WHEREAS**, *WORLD SOLUTION TECHNOLOGY, INC.*, and *GLOBAL EXCELLENCE MOTORS, INC.* submitted their post-qualification documents on November 25, 2024, and November 26, 2024, respectively, copy of the submittals are attached as **Annexes "22" and "23"**;

**WHEREAS**, as part of the post-qualification process, the BAC-A sent a letter to the Board of Investments for information regarding the status of the ongoing contract of *GLOBAL EXCELLENCE MOTORS, INC.*, copy of the letter dated November 20, 2024, is attached as **Annex "24"**;

**WHEREAS**, the BAC-A sent a letter to the Municipality of Malungon in Sarangani for confirmation of the authenticity of the documents supporting the submitted Single Largest Completed Contract of *GLOBAL EXCELLENCE MOTORS, INC.*, copy of the letter dated November 21, 2024, is attached as **Annex "25"**;

**WHEREAS**, as part of the post-qualification process, the BAC-A sent a letter to the National Bureau of Investigation, and Armed Forces of the Philippines for information regarding the status of the ongoing contracts of *WORLD SOLUTION TECHNOLOGY, INC.* Copy of the letters dated November 20, 2024 are attached as **Annexes "26" and "27"**;

**WHEREAS**, the BAC-A sent a letter to Technical Inspection and Acceptance Committee of the Philippine Army for confirmation of the authenticity of the documents supporting the submitted Single Largest Completed Contract of *WORLD SOLUTION TECHNOLOGY, INC.*, copy of the letter dated November 21, 2024 is attached as **Annex "28"**;

**WHEREAS**, Col Vito Minlo V Sarmiento, Philippine Air Force (MNSA) Commanding Officer, sent a letter confirming that *WORLD SOLUTION TECHNOLOGY, INC.* has successfully delivered their contract obligations in accordance with the terms and conditions of their contract, copy of the letter dated December 4, 2024 is attached as **Annex "29"**;

**WHEREAS**, in the BAC-A meeting held on December 4, 2024, the Technical Working Group (TWG), in their presentation of post-qualification reported that the bid of *GLOBAL EXCELLENCE MOTORS, INC.* for Lot No. 1, and *WORLD SOLUTION TECHNOLOGY, INC.* for Lot No. 2 were complying and passed all the criteria in the bidding documents. Copy of the Post-qualification Reports are attached as **Annexes "30" and "31"**;

**WHEREAS**, the BAC-A agreed with the findings of the TWG, and declared that upon post qualification, validation, and verification of all the eligibility, technical and financial requirements submitted by *GLOBAL EXCELLENCE MOTORS, INC.*, and *WORLD SOLUTION TECHNOLOGY, INC.*, its bids have been found to be the Single Calculated and Responsive Bid (SCRB) for Lot Nos. 1 and 2, respectively. Copy of the minutes of the meeting is attached as **Annex "32"**;

**NOW THEREFORE**, we, the members of the Bids and Awards Committee-A hereby RESOLVE, as it is hereby RESOLVED to:

- a) Declare *GLOBAL EXCELLENCE MOTORS, INC.* as the Bidder with the Single Calculated and Responsive Bid (SCRB) for Lot No. 1 of the Supply and Delivery of Various Brand New Transportation Equipment for NIA Region 2, Invitation to Bid No. NIACO-S-19;



- b) Recommend the award of contract for **Lot No. 1 – Supply and Delivery of Three (3) units Brand New Pick-up Truck**, to **GLOBAL EXCELLENCE MOTORS, INC.**, in the total amount of **Four Million Eight Hundred Fifty One Thousand Pesos (PhP 4,851,000.00)**;
- c) Declare **WORLD SOLUTION TECHNOLOGY, INC.** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for Lot No. 2 of the Supply and Delivery of Various Brand New Transportation Equipment for NIA Region 2, Invitation to Bid No. NIACO-S-19;
- d) Recommend the award of contract for **Lot No. 2 – Supply and Delivery of Thirteen (13) units Brand-New Motorcycle**, to **WORLD SOLUTION TECHNOLOGY, INC.**, in the total amount of **One Million Five Hundred Fifty Four Thousand Nine Hundred Ninety Five Pesos (PhP 1,554,995.00)**;
- e) Recommend the approval of this Resolution of Award to the Administrator;

**RESOLVED FURTHER**, that upon approval of this Resolution, to issue the Notice of Award to **GLOBAL EXCELLENCE MOTORS, INC.**, and **WORLD SOLUTION TECHNOLOGY, INC.** for **Lot Nos. 1 and 2, respectively**, and to enter into contract with NIA in accordance with the terms and conditions of the bid documents.
