WHEREAS, a Technical Working Group (TWG) was duly constituted from a pool of technical, and legal experts in the National Irrigation Administration (NIA) who shall perform the following functions to assist the Bids and Awards Committee -A (BAC-A) in the procurement of Various Brand-New Operation and Maintenance Equipment:

- Resolution of Request for Reconsideration. 6.

WHEREAS, the BAC-A held a Pre-Procurement Conference on February 12, 2025, to determine the readiness of the procurement of Various Brand-New Operation and Maintenance Equipment. Copy of the minutes of pre-procurement conference is attached as Annex "2";

WHEREAS, the National Irrigation Administration (NIA) advertised/posted the Invitation to Bid for the Supply and Delivery of Various Brand-New Operation and Maintenance Equipment, Invitation to Bid No. NIACO-S-22, in the PhilGEPS and NIA websites on February 14, 2025 (Annex "3"). The Invitation to Bid was also posted in conspicuous places within the NIA premises;

**WHEREAS**, observers from the COA, PICE, PCAI, NIAEASP, and NIA-IAS, were all invited to attend the Opening of Bids scheduled on March 13, 2025; 1:30 P.M., at BAC-A Conference Room, 6<sup>th</sup> Floor, Building A, NIA Complex, EDSA, Diliman, Quezon City.
